REGULATION

I. Principle: application of Law on Tender No. 43/2013/QH13 dated November 26, 2013

II. Major contents:

1. Concerned inviting party: Saovang Rubber Joint-Stock Company

- 2. Purpose:
- To find partner for supply carbon black, synthetic rubber called as materials for Saovang Joint-Stock Rubber Company 2019.
- 3. Time for supply, quantity, unit of materials:
- Details in specific offers.
- 4. Document contents required in concerning participation of supply:
- * Required documents prove the validity of suppliers including:
- 4.1 Capacity profile of suppliers
- 4.2 Financial report in 2017.
- 4.3 List of customers that suppliers have been provided materials
- 4.4 Technical standard of materials
- 4.5 Authorization letter for domestic unit (if any)

The participating document, profile should have signature and stamp of Legal Representative of suppliers.

- 4.6 Each unit should submit 01 (one) concerning profile for one package of materials on behalf of the main supplier.
- 5. Effective time sending profile for offer:

From 8:00 a.m. on day 03/12/2018 to 8:00 a.m. on day 10/12/2018 (on working hours), the profile should be directly sent to Purchase Department of Saovang Rubber Joint-Stock Company - No. 231 Nguyen Trai Street – Thuong Dinh Ward – Thanh Xuan District – Hanoi City.

III. Organization of evaluation of profiles

- 1. The Company shall open each profiles of supplies under order and inspect the validity of each profiles, consider whether the eligibility and capacity or not (point 4 section II). If the supplier shall not fully provide such conditions said above, such supplier shall not be considered. The meeting for opening the profile shall be independent from the presence of the supplier.
- 2. Profile evaluation:
- The Council shall choose to purchase goods, services Group 1, evaluate the profile, make minutes with full signature of Council members.
- 3. Notification of result:
- The concerned inviting party shall inform the result of profile consideration in writing to all units submitting the concerned profiles.



IV. Responsibility of parties

- 1. Concerned inviting party
- To ensure full information as necessity in the profile.
- To free supply profiles for the concerned participating party
